**Sat Afternoon Classes begin at 1:30 PM after BBQ Lunch**

Exhibitors must check in prior to the start of their class. Dogs will run in the order received with consideration given: to multiple dogs with the same handler, dogs entered in both IQ and a regular class, and to test workers.

**Move-ups** close 5pm, Thursday April 9 for Saturday April 11 test. Notify Test Secretary via email if you have a move-up. **Day-to-Day move-ups will be accepted** until the end of the trial on Saturday for Sunday test. No refunds for entries withdrawn after closing date for any class or in the event a dog and/or handler are dismissed from competition regardless of the reason for dismissal. Entry fees for bitches in season will not be refunded.

**AWARDS**

Qualifying ribbons will be provided for qualifying legs in all titling classes. Pale green ribbon will be awarded to any dog successfully completing the IQ test. New Title Rosettes awarded to any dog completing a title.

**THE SITE:** The Earthdog test is held on private property. Please clean up after your dogs and be respectful of the farm.

Camping & RVs are welcome, level ground for RVs, no hook-ups.

**Water:** Water is available on site. Bring shade & chairs.

**ELIGIBILITY AND ENTRY REQUIREMENTS**

Dogs six months of age or older and registered with the American Kennel Club are eligible to participate in earthdog tests, as are spayed and neutered dogs. The following breeds are eligible to participate in earthdog tests:

Dogs of an eligible breed that have been granted Indefinite Listing Privileges (ILP) are eligible to participate. A dog of an eligible breed with an acceptable foreign registration number is eligible to participate subject to Chapter 11, Section 1 of the Dog Show Rules.

Inasmuch as Dachshunds and Terriers are hunting dogs, dogs disfigured as the result of accident or injury but otherwise qualified shall be eligible provided the disfigurement does not interfere with functional movement. Blind and/or deaf dogs shall not be eligible. Blind means without useful vision, and deaf means without useful hearing. Bitches in season shall not be eligible to enter the test. Entry fees paid for a bitch that comes into season shall not be refunded.

Dogs may enter only one regular class at an Earthdog test, except dogs which have earned a Master Earthdog Title may enter more than one regular class (regular classes are classes from which the dogs may earn titles, i.e. JE, SE, ME). No further title certificates will be awarded.

A dog is not eligible to enter a test if the Judge of that test or any member of that Judge's family owns or co-owns the dog. The word "family" shall include a spouse, a sibling, a parent or child, whether natural or adopted, of the Judge but shall not extend to other blood or legal relations.

Entry fees will not be refunded if a dog is absent, disqualified, excused or barred from competition by the action of the Test Committee. *No entry fee will be refunded by reasons of weather, fire, an act of God, civil disturbance, public emergency or any other cause beyond the control of the organizing committee.*

**NOTICE TO EXHIBITORS**

Exhibitors acknowledge that they are knowledgeable of AKC rules and regulations, and agree to abide by all rules in effect at the time of this trial. The organizing committee may refuse any entry. Anyone not currently in good standing with AKC will not be allowed entry in the trial.

**RETURNED CHECKS** do not constitute a valid entry fee. \$25 fee for any check returned.

Exhibitors who do not clean up after their dogs at the site or at their motels may be dismissed from the trial.

The Carolina Terrier Association members/workers/officers will not be responsible for loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care, custody and control of his owner/handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such case, no refund of fees paid will be made.

**AGREEMENT**

I (we) acknowledge that the "Rules Applying to Dog Shows" and the "Earthdog Regulations" have been made available to me (us), and that I am (we are) familiar with their contents, I (we) waive any and all claims and causes of action that I (we) might otherwise have against the AKC and any AKC approved judge judging at this trial, under AKC rules, regulations, and guidelines. I(we) agree that the club holding this earthdog trial has the right to refuse this entry for cause which the club shall deem to be sufficient, In consideration of the acceptance of this entry and of the holding of the earthdog trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents, or trial secretary, and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the agility trial premises or grounds or near any entrance thereto, and I(we) personally assume all responsibility and liability for any such claim; and I(we) further agree to hold the aforementioned parties harmless for any claim for loss of this dog by disappearance, theft, death, or otherwise, and for any claim for damage, or injury to the dog, whether such loss, disappearance, theft, damage, or injury be caused or be alleged to have been caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I(we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person including myself (ourselves), or on account of damage to property, arising out of or in consequence of my(our) participation in this earthdog trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

**INSTRUCTIONS**

(Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (long-haired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

(Actual Owners) A dog must be entered in the name of the person who actually owned it at the time entries for a trial closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any trial for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to AKC. (For complete rules, refer to Chapter 11, Section 3.)

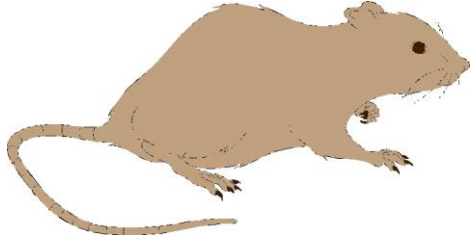
