DIRECTIONS to site:

From Greensboro, NC: Exit 147 off I-85/40 onto 87S; 11.8 miles turn LEFT on Greensboro/Chapel Hill Road (blinking light @ Eli Whitney); 0.2 miles turn LEFT on Whitney Road; 1.1 miles on LEFT Owl Hollow Farm.

From Chapel Hill, NC: 54W (Fordham Blvd.); exit Jones Ferry Road, Carrboro; at light turn LEFT; at 3rd light turn RIGHT on Old Greensboro Road (just past University Lake); 11.7 miles turn RIGHT on Whitney Road; 1.1 miles on LEFT Owl Hollow Farm.

From South (US-1): Exit 70 off US-1 onto 15/501N-87N (RIGHT at Y); 13.1 miles turn LEFT onto 87N; 16.4 miles turn RIGHT on Greensboro/Chapel Hill Road (blinking light @ Eli Whitney); 0.2 miles
